Max Theil report from the county. Kitchen inspections for non profit will have a fee increase.

Assessor report from Brian Busscher. Board of Review dates set in March. March 9 and 11. Equalization ratios had increases across the board. 1.09% was the inflation ratio this year. Discussed changes to personal property and small business exemptions. Small Business taxpayer exemption due date changed to Feb. 20th. 235 parcels visited this year, our 20% requirement was met. Assessing reform bill has not rolled out many instructions to date.
