- 3. Poverty Exemption Changes: State changed some exemptions and rules. State law now says if someone is impoverished, they should not be losing their house. If they meet certain standards, taxes may be exempt for that year. Must go through BOR + Supervisor. Assessor suggestion to put a hold on it until next year. Board agrees.
- 4. Tax Collection Agreement Hamilton Summer Taxes = \$i3.05/parcel. Reinart motion let treasurer sign agreement, Commons supports.
