#### Reports

- 1. Visiting Officials:
  - a. Max Theile ARPA Money; 3 main reasons to use money. County to receive 22 million. Board is still unsure how to use their funds. Broadband issue has been placed on a list of other possible ideas. As of right now, funds will not be used for awhile (at least till the end of this year)
    - i. Board have set up a Broadband Work Group. Members will be chosen at next meeting (8/5/21). Gerry Williams has applied and application received was notified that will meet every 2 months as of right now.
  - b. Jim Storey (chairman of County Board) Here for Mental Health Board. Here to interduce Director, Mark Witty.
    - i. Mark Witty One 6/24/21 requesting portion of our ARPA funds to help fund other governmental units/depts. (RL Loan to buy/refurbish). With COVID Bids way higher (1.5mill gap). Mental Health office many services throughout the county for all residents.
- 2. Assessors: July Board of review principle residency exemptions who didn't file on time but completed.

  - b. EMS Met 5/2021. Board will be writing letters to send out to local governmental units for requesting a portion of ARPA funds. Did order 2 ambulances will be here between Nov.-Jan. Raised wages for people on ambulances.
  - c. Library Starting to plan Taxation Hearing.

  - a. Reinart approve site plan on the condition that the lot is expanded as presented on site plan. DeHaan supports.

- 6. Gypsy Moths Received a lot of complaints about moths. Previous business used before out of business. Board decided to sit on it and will discuss at later time.
- Tire Recycling Grants provided by County to have residents to recycle Tire. 8/7/21 at Salem Transfer Station and Trowbridge Township. Also on 8/14/21 – location TBD/registration required. Flyer available by request
